

Just to bring you up to speed:

......We have been contacted by a barrel racing group that is a division of KOBRA that is interested in utilizing our grounds for both individual barrel races and a possible series of barrel races for overall awards. The first date they have requested is November 5. Let's hope that this is the first of many dates they request for our facilities.

......As you might recall, our 2007 taxes were filed late. "We were contacted recently by the IRS regarding the late filing fee and after discussions with our accountant, Kelli Parr, it was decided that we should move forward and pay this late filing fee. The cost if we paid before the end of September was \$1745.00. Had we waited, we would have incurred additional costs, so we thought it best that we move forward on this and pay it at the time. Kelli assures me that if for any reason the IRS decides that they will forgive this, we can recover these funds (though she does not hold out much hope that this will be the case). She is still in negotiation with the IRS regarding the misfiling of the 2005 taxes. We are hopeful that the issue with the 2005 taxes might FINALLY be resolved this year with no additional outlay of funds by the Association. I will keep the membership abreast of our progress in this regard.

Loretta addressed there being no place to display club awards so we should discontinue giving them out.

Heath said cable is hard to repair. Donna discussed how she replaced the cable in her stall. Becky thinks the association should be making repairs for tenants.
