I hereby agree to the following provisions of the AMERICAN ASSOCIATION SHERIFF POSSES AND RIDING CLUBS, herein referred to as the AASP&RC in order to be permitted to construct permanent horse stall (10X10) on the AASP&RC grounds, at Bowie, Texas. For my immediate family's use during the AASP&RC functions.

- 1. Stall site(s) will be designated by AASP&RC President.
- 2. These stalls are subject to inspection by the AASP&RC President or his designees and any deviation from the attached building specs will be corrected.
- 3. Only myself or my immediate family (including married children) may use these stalls. As long as I or my immediate family are members of the AASP&RC..
- 4. Stalls are to be constructed in groups of 10 with 20 connected. A 20' alley is to be between each group of twenty. Stalls must be covered.
- 5. Stalls are to be constructed per the above specs.
- 6. No stallion (s) are allowed in stall (s).
- 7. I will be responsible for clearing and cleaning stall barn sites immediately upon completion of construction.
- 8. All materials used in construction must be of good quality and are subject to inspection by the AASP&RC President.
- 9. Your stall may be transferred. When stalls are transferred from one member to another each party must sign a letter of intentions with barn and stall number attached. Stalls are to be transfer for no more than the original cost. (Passed by the delogates at the convention October, 1992.)

10. If I or my immediate family is not pre-registered 10 days before a function for that specific function, the AASP&RC may rent the stalls to someone else with the proceeds going to the AASP&RC.

11. I will furnish all materials and labor to construct my pre-rental stall(s). It is my responsibility to maintain (paint, weld, etc.) the stall (s).

This agreement must be signed and filed in the AASP&RC office. In return for the above agreement, I and my immediate family will be guaranteed the above stall (s) for all AASP&RC functions held on the grounds at Bowic, Texas for life, provided the above provisions have been met.

#### NAME THE GAME

The AASPRC is having a contest to name the new game that will take the place of Bowtie next year. The contest is open to all juniors, pee-wee and super peewee members. Please, parents and older siblings, this needs to be their idea.

**Race description:** The rider crosses the timer line either to the right or left set of poles. Rider goes on the outside of the first pole, inside the second, outside the third. Going around the barrel, rider proceeds to the second set of poles, going outside the first, inside the second and outside the third and crosses the finish. **Equipment required:** Six (6) standard poles; one (1) 55 gallon barrel w/ pad **Measurements:** First pole is thirty (30) feet from starting line

Poles are thirty (30) feet between each going down the arena Poles are sixty (60) feet apart across the arena Barrel is centered in the pattern and thirty (30) feet vertically from last pole

**Penalties:** There will be a five (5) second penalty for knocking over each pole or the barrel.

**Disqualifications:** Failure to run a correct/complete pattern **Judges:** At least two (2) judges, one on each side of the pattern
