Hello all!



NAME THE GAME

The AASPRC is having a contest to name the new game that will take the place of Bowtie next year. The contest is open to all juniors, pee-wee and super pee-wee members. Please, parents and older siblings, this needs to be their idea.

Race description: The rider crosses the timer line either to the right or left set of poles. Rider goes on the outside of the first pole, inside the second, outside the third. Going around the barrel, rider proceeds to the second set of poles, going outside the first, inside the second and outside the third and crosses the finish.

Equipment required: Six (6) standard poles; one (1) 55 gallon barrel w/ pad

Measurements: First pole is thirty (30) feet from starting line

Poles are thirty (30) feet between each going down the arena

Poles are sixty (60) feet apart across the arena

Barrel is centered in the pattern and thirty (30) feet vertically


from last pole

Penalties: There will be a five (5) second penalty for knocking over each pole

or the barrel.

Disqualifications: Failure to run a correct/complete pattern **Judges:** At least two (2) judges, one on each side of the pattern



Executive Board Meeting, June 15, 2011

The meeting was called to order at 9:35 AM.

Roll call was taken by Jeton Tumlinson, we had 39 voting representatives.

UB Herrington gave an invocation.

The first item on the agenda was to officially vote in Wayne Moody as the Region 2 VP. Vote was accepted.

Lauren O'brien was introduced and spoke to the assembly.

Minutes where waved as everyone has read them. The motion was made by Tommy McEwen and seconded by Summer Savage. Motion carried.

Loretta Jeter gave an update on Convention and what was needed to be decided. The Convention will be at the Hilton Garden Inn in Denton. It will be on Oct 14 thru Oct 16, 2011. Loretta brought up the idea of starting the delegates meeting of Friday and continue on Saturday. Discussions went on about how, when and where. There will be a luncheon on Saturday and after the voting is done, we will install the officers. The meetings rooms will cost \$500.00 and Region 3 is going to try to raise the money to pay for them. The suggestion was made that there will be no dinner and dance at convention, because we have no Queens's contestants. Discussion was continued on what was needed at convention.

Diane Johnson made a motion to start the Convention on Friday night with a Social gathering around 5:00 PM and then go into the Delegate Meeting around 7:00 PM allow time for people to arrive after getting off work. The meeting on Friday night would go on until 10:00 PM and then resume on Saturday. Varsi Klatzkin seconded the motion. Motion carried.

It was also brought up that the delegates meeting resume at about 9:00 on Saturday, with lunch being served and awards at the appointed time. All of this should be worked out by the Convention Chairperson. With the cost probably remain the same as last year, \$50.00. Registration must be registered as early as October 1, 2011.

Annette Waggoner then gave the report on the Queen's contest. She presented a guideline and it is attached for everyone to read. This guideline is to be considered for finalization at convention.

Loretta Jeter brought up the subject of the scholarship that was voted on at last year convention. Renee said she is aware of it and is planning on having it available this year.

LaDonna Mild then asked if anyone has any suggestion for the web site, to please let her know. Also if we could help with the information on Regions, District and clubs please get it to her.

Kathy asked for everybody that has the time please come help at all the events.

Rick Fitzgerald that when there is a nominating meeting held that each Region provide a representative.

Eric Savage announced that we raised \$147.00 for the Intrepid Warrior program at Playday Finals. A check will be given to Eric to write a letter and mail to said charity. Eric asked for suggestion to raise money for the charities.

Larry Mitchell gave the report on the Rules Committee at Playday Finals and said their where some discussions but for the most Finals was good. He also said that he forgot about the vote on the name for the new event. The information would all be in the Riders Roundup.

Misty Martin, Special events Chairperson was thanked and had nothing to report. Misty also thanked all the people that help her throughout the year.

Don McEwen had nothing to report at that time and was thanked by everyone.

Over the year, Renee tried to get people to take the Audit Chairperson. Diane Johnson was introduced as the new Audit Chairperson. Until Diane gets all the information she cannot give an accurate report on the mishaps of the past year. All items that Diane has seen do not lead up to charges, everything is circumstantial. There may be other items charges that may have been misappropriated. Questions were asked about the financial statement. Kelly Parr has not been providing any financial statements. Renee explained the sequences of receiving the mail and paying the bills.

A motion was made by Rick that Peggy be allowed to open the bank statements and Charmie seconded it. Motion carried.

The question is online banking and it was explained that the banking rules will not allow us to have that. It is also was asked why we had to have two Post Office Boxes. It was explained that there where bills and statements necessary that the two boxes stay.

Garland asked about the Memorial Wall. Jeton said that they just haven't had the opportunity to get to Bowie. It was also put out that they are not the only one responsible for doing it alone.

Ronnie Elrod asked that we get a quote on buying new speakers. It was brought up that if expect to rent out the arena that we should keep the announcing system in working order. The speaker being part of that system and the arena has been rented to the Texas Smokin Guns for the 4th of July weekend. There was motioned by Larry Mitchell and seconded by Rick Fitzgerald that we get the new speaker and try to get the system in working order before that weekend. Motion carried.

Corey has got the price down to \$800.00 for Radio system. Corey Waggoner brought up that at convention last year that we voted to install a radio broadcasting system and that we should also do that upgrade while we had the equipment at the arena. A discussion was had and it was decided that we now had the money and we should go ahead with the installation. Corey made a motion and Loretta seconded it that we get the Radio system and speakers be done at the same time. Motion carried.

Discussion was started on what the problem was with the speakers and what was needed to replace the speakers and wiring. A plan was set up and will be taken care of. It was discussed if we have the

money or not and we should go ahead while we have the money. If we are going to rent the arena out, we should provide the speaker system that works.

The Association had received an application from Daniel Leipsic to allow him to join the Association under his own membership. After much discussion and several factors being pointed out, it was decided that until all legal matters are cleared up, we would refuse Daniels' membership. At this moment we have no idea as to a time line for wrap up and involment. Eric Savage made a motion to end discussion on this subject and the motion was seconded by Jeton. Motion carried.

Renee asked if there was anything else to discuss. Renee said she will put into place a scholarship chairperson and we will pursue a scholarship winner. Donna Rust asked about repairs to stalls that member have used and damaged.

Loretta made a motion to adjourn and seconded by Jeton Tumlinson.

Varsi asked that we do something to make sure that junior and below receive award for 7-10th place. It was explained that in the bylaws that state awards are for 1-6th place. If money is available, lower awards will be given. Discussion was had on this subject. It was asked that what places be advertise better

A motion was made to adjourn the meeting by Loretta Jeter and seconded by Jeton Tumlinson. Renee said she had a few other things to discuss, a vote was taken and it was voted to adjourn the meeting. The vote was 17 to adjourn and 11 not to.

- 4. A 5 X 7 PICTURE TO BE RUN IN THE RIDERS ROUND-UP.
